TARGETS:

Slow Fire – B16
Timed & Rapid Fire – B8

COURSE OF FIRE: .22 – Centerfire - .45

Slow Fire – (2) 10 shot strings – 10 minutes each
National Match – Slow Fire – 10 shots – 10 minutes
Timed Fire – (2) 5 shot strings – 20 seconds each
Rapid Fire – (2) 5 shot strings – 10 seconds each
Timed Fire – (4) 5 shot strings – 20 seconds each
Rapid Fire – (4) 5 shot strings – 10 seconds each

All firing will be done from 25 yards on standard NRA approved targets.

RULES & CLASSIFICATIONS: All current NRA rules will apply throughout the match. The classes will be as follows: High Master, Master, Expert, Sharpshooter, Marksman & Unclassified.

AWARDS: There must be at least 4 competitors in a class before there can be an Award. Any class that does not have the minimum number of competitors in it will be combined upward. There will be an additional Award for each additional 4 competitors in a class. Awards will be based on a minimum of 50% return of the match entry fees less expenses.
