Rifles: Service rifles as defined by the CMP.
Ammunition: Competitors will supply their own safe ammunition.
Course of Fire: SR target-200yds.,SR-3 target-300yds.,MR target-600yds
 Stage 1: 10 shots in 10 minutes, standing, slow fire, 200 yds.
 Stage 2: 10 shots in 70 seconds, standing to prone, rapid fire, 300 yds. NO alibis.
 Stage 3: 10 shots in 10 minutes, prone, slow fire, 600 yds.
 There are no sighting shots at any time or any distance.

1000 **Entries Close for EIC match.**

1200 **EIC match begins.** P100 match not required to enter.
EIC Rifles: Service Rifle as defined by CMP rule 6.2.1, 6.2.2, 6.2.3
Ammunition: Competitors will supply their own safe ammunition.
Course of Fire: SR target-200yds.,SR-3 target-300yds.,MR target-600yds
 Stage 1: 10 shots in 10 minutes standing, slow fire, 200 yds.
 Stage 2: 10 shots in 60 seconds, standing to sitting, rapid fire, 200 yds.
 Stage 2: 10 shots in 70 seconds, standing to prone, rapid fire, 300 yds.
 Stage 3: 20 shots in 20 minutes, prone, slow fire, 600 yds.
CMP rules apply. There are no sighting shots at any time or any distance.
